- 2. Tenders can be submitted online at "etenders.kerala.gov.in", by searching with our tender ID.
- 3. Payment of EMD Rs. 12500/-(twelve thousand five hundred only) through internet banking while submitting the tender online. SBI, multi option payment system (MOPS) has been integrated in to E-procurement portal and NEFT/RTGS modes have been disabled. Bidder may remit tender fee/EMD via MOPS only. Bids with successful EMD only will be treated as valid tenders.
- 4. The bidder has to click "YES" for claiming exemption of EMD. The bidder has to upload an EMD exemption certificate.

- 6. Agreement shall be executed by the successful Tenderer before commencement of supply.
- 7. EMD submitted along with the tender will be released only after finalization of the tender without any interest.
- 8. If supply is not completed within the schedule time, penalty will be imposed @ 0.5% per week subject to a maximum of 5% of the delayed portion.
- 9. Supplied dry roaster and accessories shall be guaranteed for a satisfactory operation for a period of 12 months from the date of commissioning. Any defect noticed during this period shall be repaired/replaced free of charges.
- 10. 90% payment with GST will be released immediately after receipt of materials and balance 10% after satisfactory erection of the dryer.
